LIFETIME LIMITED WARRANTY

Duration and Scope of Limited Warranty: Diamond® and Nimble™ by Diamond® Cabinetry (“**Diamond Cabinetry**”) warrants the original consumer purchaser for as long as they own their home that the Diamond Cabinetry products (“**Product(s)**”) will be free from defects in material and workmanship under normal use (“**Warranty Period**”). This Limited Warranty is only applicable to Products used in residential applications within North America (excluding the Province of Quebec) and is not transferable to subsequent owners.

Warranty Limited to Repair or Replacement: Should defects in material or workmanship exist during the applicable Warranty Period in any Product, Diamond Cabinetry will elect at its discretion to either repair or replace the defective Product material or component, free of charge. This Limited Warranty covers only parts and materials of the Products supplied by Diamond Cabinetry.

Exclusions: Not covered under this Limited Warranty are **[Note: In previous cabinet warranties, we have also listed the following: flooring, tile, sinks, accessories, wall coverings or treatments. Consider whether you may want to include these here.]** counter tops, appliances, plumbing fixtures, etc. or the costs, including labor, to remove and reinstall Product materials and related components such as fittings, appliances, etc.

This Limited Warranty shall become void if the Products are in any way modified, improperly installed or damaged prior to or during the installation.

This Limited Warranty will not apply to Products damaged by misuse, neglect, abuse, acts of God, exposure to moisture, exposure to extreme temperatures or the effects of normal wear and tear.

Natural woods may vary in color, characteristics and exhibit subtle changes as they age. For example, white painted face frames may eventually have visible cracking around the joint area and cabinet colors may darken or lighten over time. Sunlight, smoke, household cleaners and other environmental conditions may also affect the color match over time. These variations are considered to be the nature of the material in relation to their environmental exposure and are not covered by this Limited Warranty.

Diamond Cabinetry reserves the right to alter design, specifications and material without obligation to make similar changes to Products previously manufactured.

Warranty Claim Repair, Replacement; Obsolete Products: The repair(s) or replacement(s) are contingent upon the current Product offerings of styles and construction options within the Products at the time of the Limited Warranty claim. If a claim under this Limited Warranty is filed after a Product becomes obsolete; Diamond Cabinetry reserves the right to honor this Limited Warranty in one of the following fashions:

1. To replace the affected Product component of the same style.
2. To replace the affected Product component and any other Product component(s) in the residential application to achieve a uniform appearance with a similar and comparable Product style of the originally purchased style.

If Product components are replaced, Diamond Cabinetry cannot guarantee that the finish of these replacements will exactly match the finish and appearance of the Product components in the residential application. This is due to the changes that occur during the woods' natural aging process, affecting its color and grain.
